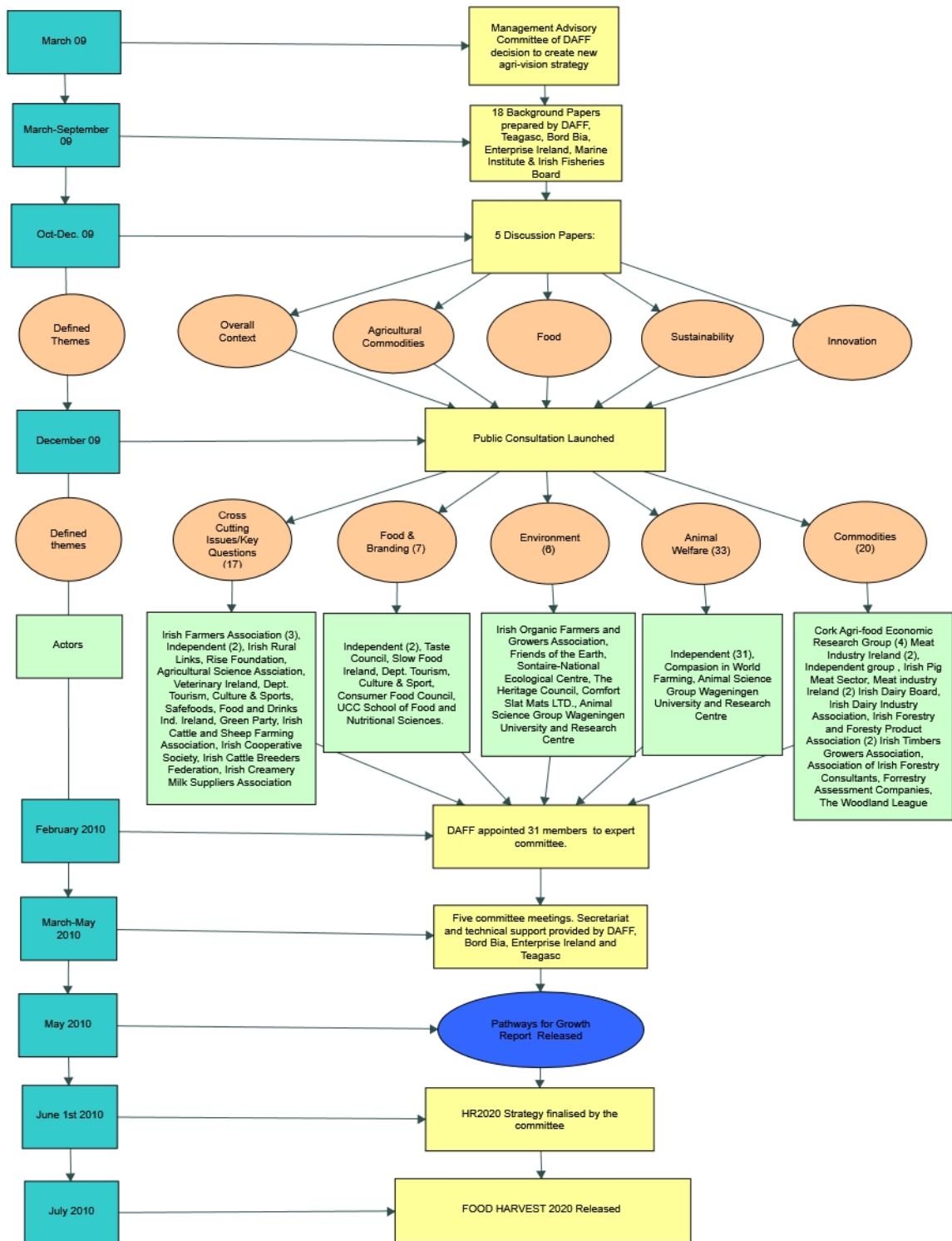

**Table 2: The roles of key actors responsible for preparing the initial draft of FH2020 prior to initiation of committee meetings**

Actor	Sector	Summary of Roles and Responsibilities
<b>DAFM formerly DAFF</b>	Government	Responsible for the promotion and development of Irish agriculture, food and rural areas. The DAFM is also responsible for regulation of agriculture, fisheries and food industries and for monitoring and controlling food safety (DAMF, 2016).
<b>Bord Bia:</b>	Government	The Irish Food Board (Bord Bia) is a state agency under the guidance of the Minister for Agriculture, Food and the Marine. Bord Bia is tasked with promoting the sales of Irish food and horticulture in Ireland and abroad (Bord Bia, 2016).
<b>Teagasc</b>	Government	The Agriculture and food development authority in Ireland which ‘support science-based innovation in the agri-food sector and the broader bioeconomy that will underpin profitability, competitiveness and sustainability’ (Teagasc, 2016).
<b>Enterprise Ireland (EI)</b>	Government	Responsible for the ‘development and growth of Irish enterprises in world markets’. They work with Irish businesses to help them ‘start, grow, innovate and win export sales on growth markets’ (EI, 2015).

**Figure 2. The Policy Triangle Framework adapted from Walt & Gilson (1994) as applied to FH2020 in a summarised version.**

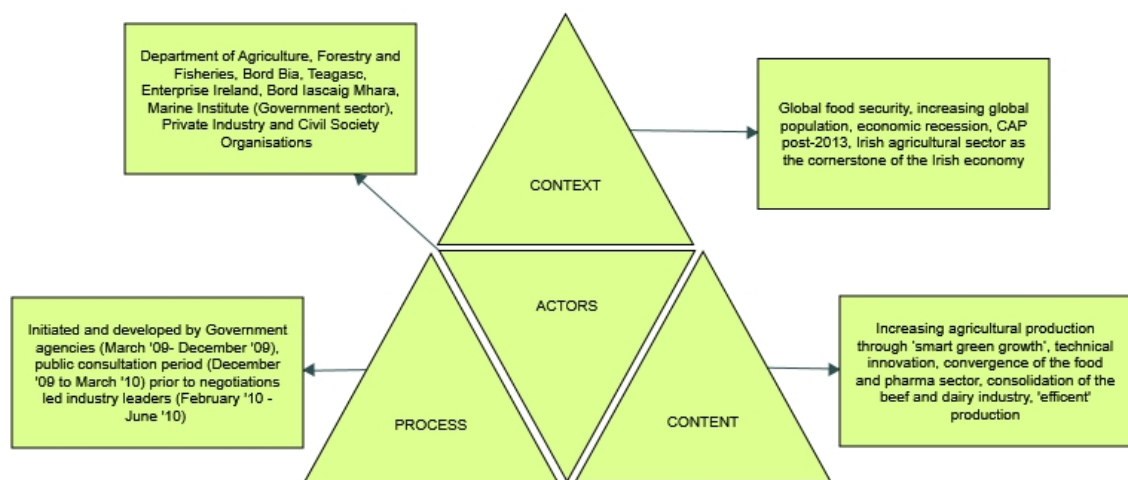


Figure 2 presents a summarised overview of the key actors involved in the development of FH2020, the process and context of development, and the content in terms of common themes and issues prioritized.
