3. **Restricted Access:** The final thesis may not be viewed or downloaded by anyone at any time. This option can only be selected in exceptional circumstances and a justification must be provided for requesting the restriction.



### \*Embargo

During a designated period, the final thesis may not be viewed or downloaded on CORA. An embargo can be implemented for periods of 1, 3, 5 or 10 years on a thesis under **Open** or **Controlled** access



### Redaction

Certain sections of the final thesis can be censored or removed from the thesis prior to being made available under **Open** or **Controlled** access. This accommodates cases where the author wishes to disseminate their thesis but is unable to publish certain sections of the thesis
