Figure 1. FH2020 Timeline, Process, Actors, and Pre-defined Themes.



Figure 2. The Policy Triangle Framework adapted from Walt & Gilson (1994) as applied to FH2020 in a summarised version.




Figure 2 presents a summarised overview of the key actors involved in the development of FH2020, the process and context of development, and the content in terms of common themes and issues prioritized.
