CONTINUING PROFESSIONAL DEVELOPMENT

Children and the European Union: Legal, Political and Research Perspectives

20th - 22nd April 2009, University of Liverpool, UK

The principal aim of this three-day conference is to generate in-depth discussion of developments that have taken place at EU level in relation to children's rights and welfare. This will mark the first critical multi-disciplinary conference to assess this area of EU law and policy and will involve policy-makers at both domestic (Europe-wide), EU and international (including UN) level, practitioners, representatives from the NGO sector, and academics.

The event responds to the landmark 2006 Commission Communication which paved the way for the development of the EU Strategy on the Rights of the Child. The conference will also debate the impact of the Lisbon Treaty on the status of children and the extent to which this paves the way for a more strategic and robust EU children's rights agenda.

Critically, the conference will provide an invaluable opportunity to engage in critical, cross-disciplinary debate as to the value of EU regulation of children's rights, with a particular focus on how this could complement the children's rights campaign at both national and international level.

The Parents Plus Children's Programme is an evidence-based* group intervention designed to empower parents to promote their children's (covering ages 6 to 11) development and learning as well as to manage discipline and behaviour problems. Participants will learn how to facilitate the PPCP in clinical and community settings, with children within the normal range of development as well as children with more complex needs.

During the training, participants will be shown not only how to facilitate the Parents Plus Programme with small groups of parents, but also how to use the ideas in their existing work with parents, children and families. Central to the training is a strengths-based model of working with parents strengths and empower them to find the best solutions for their families.

*Parents Plus Children's Programme Research

The multi-site study on the PP Children's programme is now complete and has been accepted for publication in the journal *Clinical Child Psychology and Psychiatry*. The study compared outcome for 74 parents of children attending the PPCP group and 42 parents who completed Treatment as Usual (TAU). Compared to the TAU Group post-programme, the PPCP Group displayed significant reductions in total difficulties and conduct problems as measured by the Strengths and Difficulties Questionnaire, decreased parental stress, increased parental confidence and significant improvements in parent-defined problems and goals. These positive changes were maintained at five month follow-up for the PPCP group, in addition to further significant improvements in peer problems and prosocial behaviour.

Postgraduate Diploma in Advanced Fieldwork Practice and Supervision (Social Work) 2009 - 2010

The Department of Applied Social Studies has been running this course since 2001. We have approximately 60 graduates located at various agencies throughout Ireland. The course is accredited by the National Social Work Qualifications Board . It is the only externally accredited, post qualifying social work course in the Republic of Ireland.

The aim of this programme is to prepare relatively new and experienced social workers for the task of practice teaching and supervision of social work students. The programme is part-time and run on a Friday over the period from mid September to the end of May. Participants attend the university two Fridays every month and they have peer support and library study on the other Fridays. This course offers a balance of theoretical inputs, experiential learning, self directed and library study. It involves on the job supervision of a professional social work student (MSW/BSW) while on placement, over a 14 week period (January-April).

The course team is committed to developing and supporting the philosophy and practice of reflective learning throughout the course. The course embraces a humanistic, person centred value base, beginning with a focus on participants existing knowledge, skills and competencies. Learning is presented as a continuum and new learning is represented as a development on from participants' previous experiences. Providing participants with opportunities to reflect on their own practice and to reassess their own learning in the light of new knowledge and experience is an important focus throughout the course.

Participants are tutored and supervised while on the course. Group work is the main method of teaching and learning on the course and lecturers and tutors encourage participants to bring their practice experiences into the classroom thereby, enriching the whole learning experience for all participants.

Evaluations of the course with course participants and graduates have informed us that the course has had a value and merit way beyond practice teaching and student supervision. Many of our past graduates have gone on to further study and others have been promoted within their agencies to team leader, senior practitioner and other senior positions.

As the reality of social work registration comes down the track, we believe this course will be an important one in terms of providing social workers with opportunities to pursue further professional studies.

HEALTHSTAT - HSE Ireland

Health and social care services hold a wealth of information about the services that they deliver. Despite this, it can be a challenge to put a finger on the pulse of service performance. To be able to stand over our work, and to enable continuous improvement, we need reliable, timely and comprehensive information about how our services are delivering. To meet this need, the HSE has designed and implemented a performance information and improvement system called HealthStat.

HealthStat is a comprehensive databank of performance information from Irish public health services. It currently provides detailed monthly results from 29 teaching, regional and general hospitals, which are published online on this website. Later in 2009, HealthStat will expand to cover additional general and specialty hospitals and in 2010, all health and social care services provided in the community by Local Health Offices will be included.

HealthStat works on the basis of measures – how a hospital is delivering services, and targets – what we expect from a well performing service. Hospitals get marks on three themes : Access, Integration and Resources:

- * Access measures waiting times for hospital services
- * Integration checks whether the services received are patient-centred
- * Resources looks at how staff and financial resources are being used

Newly-Qualified Social Worker (NQSW) scheme for social work in adult services (SCIE, United Kingdom)

The Department of Health is working with Skills for Care, General Social Care Council (GSCC) and SCIE to develop a Newly-Qualified Social Worker (NQSW) scheme for social work in adult services. A similar framework is being introduced for NQSWs in children's services.

As part of this work, SCIE has been asked to draft for comment a set of Outcome Statements for social workers with adults, their families, carers and communities. The Statements seek to capture the core elements of social work practice in adults' services, so as to enable a NQSW to demonstrate after an initial year in employment that they are a competent social worker. See below for an explanatory letter and questionnaire for responses, the headline definitions for the 12 proposed outcome statements, and an exemplar to show the kind of detail to be included in each statement.
